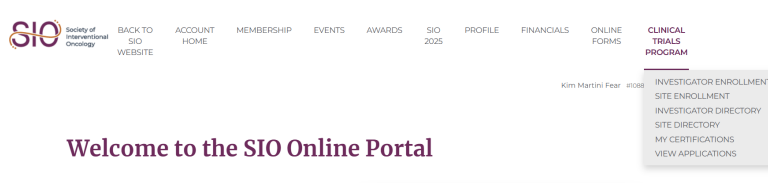
The Clinical Trial Collaborative Basic Principal Investigator online course is a FREE training course. We encourage you to enroll whether you are a Member or a Non-Member of the SIO, and if you represent from multidisciplinary specialties. The training is not specific to Interventional Oncology, rather to competencies needed to be a Principal Investigator.

There is no charge for enrollment into the Directory as a Principal Investigator or Sub Investigator and we accept all. There is also no charge to enroll an Institution. Currently, we only accept US and Canadian sites for enrollment.

SIO requires a brief [log in process](#) with completed profile information to access the enrollment forms or the online course. Please follow the directions and screenshots listed below, and reach out to info@sio-central.org for assistance if needed.




